- 1. Call meeting to order & establish quorum:** 6:01pm (Carlos); we have 3 of 5 Board members present, quorum has been established.
- 2. Review & approve of meeting minutes from October 29, 2024:** Carlos motions to approve the minutes as written, Victor seconds, motion carries.
- 3. Financial Review (YTD, December 31<sup>st</sup>):** Through the end of December, we have a total operating income of \$204,777.74 and a total operating expense of \$121,272.66.
  - a.** One of the CD's matured at the end of December and we are waiting on our contact with United Bank to provide the current rates; Rocktown will email the Board for approval once those have been received.
- 4. Community Update:**
  - a.** Old Richmond Playground – The new playground equipment was installed and the landscapers leveled the soil and added fresh wood chips.
  - b.** Dog Park Trash Sign – A “No Dumping” sign was installed on the corner of Emerson and Victorian Village to try and prevent that area from being used for bulk items.
  - c.** Vehicles – There are a few vehicles in the community that have expired tags or no tags; Rocktown will tag each vehicle and have them towed.
  - d.** Snow Removal – This most recent snow was difficult due to the amount and the cold temperatures. The landscapers have done the best they could with clearing the roads and parking areas.
  - e.** CTA - This is currently suspended but will likely reactivate again, and Rocktown still needs FinCEN numbers from a few Board members to file the report.
  - f.** Sales – There is one active listing in the community, 1201 Wordsworth. The units that sold in 2024 ranged from \$235,000 – \$280,000.

  - i. Rocktown will get it re-installed.
- b. Carlos brings up units that had their roofs replaced with shingles that don’t match.
  - i. The Board asks if quarterly reminders could be sent out with information on the approved shingles and color.
  - 1. Rocktown will send reminders out and include the ARC Guidelines document each time.
