- 1. Call meeting to order & establish quorum:** 6:00pm (Michael L.); we have 4 of 7 Board members present to begin the meeting, quorum has been established.
 - a. Nasir joined the meeting at 6:16pm to give us 5 Board members.
- 2. Review & approve previous meeting minutes from November 16, 2023:** Michael L. motions to approve the minutes as written, Holly seconds, motion passes.
- 3. Manager's Report:**
 - a. Delinquency: Court is scheduled for next week for 4 remaining delinquent owners in the community.
 - b. Basketball Court: We are currently working on obtaining estimates for the concrete slab and a fence for a possible basketball court in a common area of the association. The estimates will be presented to the Board once they have been received.
- 4. Financial Review (YTD, December 31st):**
 - a. Through the end of December, we had a total operating income of \$80,413.18 and a total operating expense of \$73,413.70.
 - b. The common areas have been handed over to the association. Rockingham county has re-classed them and waived the 2023 second half fees. The common areas are now non-taxable.
- 5. Old Business:**
 - a. ARC Design Standards: Rocktown will add what the setbacks are from the governing documents to the document and then redistribute to the Board for an email vote. Once this has been approved, it will be posted to the website and sent to the community.
 - b. Rules & Regulations: The document for rules and regulations is discussed by Board members and Holly will work on editing it. Once the final draft has been approved, the document will be posted on the website and sent to the community.

- a. Fran I. mentions there is still an issue with speeding on Suffolk and that the police were contacted and stated they would patrol the area.
 - i. Rocktown will follow up with Sheriff's department about this.
- b. Jason F. thanks the Board for their hard work this past year.
- c. Brent U. also thanks the Board. It is also mentioned that if basketball hoops are removed, a replacement is needed for the children in the community to have somewhere else to play.
- d. Melanie E. is willing to help provide input regarding the walking trails and what is needed to clean them up and maintain them. She will do a walk through and provide feedback to Holly to help create a scope of work.
 - i. She also mentions there are signs near the walking trail that state 'Beware of Dog' and 'Area under surveillance.'
- e. Michael L. states that the flag at the entrance is torn and needs to be replaced and the flagpole is wobbly and needs to be stabilized. Rocktown will have this taken care of.
 - i. Mentions that the light poles in the community are outdated, so we can decide if the association wants to update them.
