

# *The Townes at Wellington Park*

## *Property Owners Association*

### **Rules and Regulations**

The following policies or guidelines have been established by the Association in the interest of helping keep your neighborhood safe, neat and attractive.

- Each unit is allowed two parking spots, if a unit has more than two vehicles and those can be parked in the overflow spots but not the visitor spots. The two allotted parking spots cannot be used for boats/watercraft, commercial vehicles or recreational vehicles. No disabled vehicles or vehicles with dead registration plates. The POA has the right to tow any improperly parked vehicle. A 48-hour notice will be hung on the vehicle, and if not moved within those 48 hours it will be towed. **Towing services provided by JL Towing – 540-434-4448.**
- No property is authorized to conduct a business, manufacturing, mercantile, storing, or other non-residential purposes.
- Only 18"x24" for sale or for rent signs allowed and a small security system sign per lot.
- No noxious or offensive activity shall be carried on upon any lot. Nor shall anything that may become a nuisance to the neighborhood is to be conducted.
- No temporary structures such as tents are allowed. Garages cannot be turned into a living space.
- No Livestock or poultry of any kind. Only house hold pets, such as dogs and cats allowed. Pets must be on a leash and pet waste must be disposed of immediately. There is a **\$50 fine per violation.**
- Cigarette butts must be disposed of properly. Do not throw them on the ground or off into the grass/mulch. **An immediate minimum charge of \$50** will be assessed to resident

and owners if grounds keeping needs to clean up cigarette butts. Throwing cigarette butts into someone else's area will not be tolerated.

- All indoor furniture must be kept indoors, and the exterior patio/deck areas kept neat and clean. Couches, indoor chairs, plywood, appliances, etc. may not be left outside or on decks. There is a **\$50 per violation**.
- Sliding screen doors and window screens must remain installed or placed out of sight inside the respective unit. There is a **\$50 fine per violation**.
- All trash shall be put in designated areas in closed approved containers. There **will be a minimum \$50 fine** if grounds-keeping must pick up trash by your unit.
- No outside television antenna, satellite dish, direct broadcast satellite dish or similar structure unless approved by the Board of Directors.
- Any lease agreements between owner and lessee, must be no shorter than six months.

**Violation Procedure:** A photograph will be taken of the violation(s) and a warning notice will be placed on the door along with an email to the owner of the violation. If the violation is not fixed within 10 days a \$50 fine will be placed. If another 10 days go by and the issue is still not resolved a \$100 fine will be placed. If a third notice is needed, a lien will be placed on property in violation to include any interest, reasonable attorney's fees, and disbursements and costs of collection incurred by the association in connection therewith.
